1. The Santuck Flea Market is held on the FIRST SATURDAY of the month, **March through December**. There is no market in January or February. Flea Market hours are from daylight until 2:00 p.m. Grounds must be cleared by 4:00 p.m. **Vendors need to be set up by 6:00 a.m. Vehicles will not be allowed to enter the vendor area after 6:00 a.m. because of danger to pedestrians.**
2. Space rental is \$25.00, which is **PAID IN ADVANCE**, and non-refundable. **PLEASE HAVE CORRECT CHANGE. Spaces are rented by reservation only.** Spaces are approximately 19' wide x 18' deep. You must stay within your space. Vendors must sell merchandise. **DO NOT let someone else rent your space. If you are not coming, notify management as soon as possible.**
3. Electricity is \$5.00. This is **ONLY** for those vendors who need electricity to **SELL** their products. It is not for heaters, air conditioners, camper trailers, etc.
4. The Santuck Flea Market **will go on** Rain or Shine on the scheduled Flea Market day (do not have rain-out date).
5. **It is the vendor's responsibility to come by the office and pay space rental sometime during the day on Friday or Saturday of flea market. Office opens 1p.m. till 7:00 p.m. Friday before market and 4:30 a.m. until 2:00 p.m. on flea market Saturday.**
6. **VENDORS ARE RESPONSIBLE FOR LEAVING THEIR BOOTH AS THEY FOUND IT. THERE WILL BE NO TRASH LEFT HERE. VENDORS ARE RESPONSIBLE FOR TAKING THEIR TRASH WITH THEM. IF IT CAME WITH YOU, IT WILL LEAVE WITH YOU!!!! THIS WILL BE ENFORCED.**
7. No food, drink, pets, chickens, rabbits, ducks, etc. can be sold.
8. No pets allowed on grounds. (Vendors please do not bring your pets).
9. No PA systems or games of chance allowed.
10. NO ALCOHOL or PORNOGRAPHIC MATERIALS are allowed on the premises.
11. AN ELMORE COUNTY VENDOR'S LICENSE IS REQUIRED BY ELMORE COUNTY. Probate Office, Elmore County Court House Downtown Wetumpka (334) 567-1142.

13. **ONLY OFFICIAL GOLF CARTS AND/OR MEDICAL CARTS ARE ALLOWED.**
